"Howdy. Hope all well with you. We're all working on our new norm and Michelle has called couple times and says she's doing good and is safe and has nice and humorous roommates. She starts working in kitchen Monday 6/10 from 1pm til 7:30pm. Says plenty during regimented days to keep busy and the days fly by.

Here's info from Michelle that we've been waiting for. To visit you have to be on list so you can type online "Women's Prison Shakopee MN" and go to website, then under link "Family & Visitors" select "visiting information" then scroll down to "Visiting Applications" and select "Visiting Privilege Application Form" (it says "fillable online English"---and you may be able to fill out online but all applications have to be printed out and mailed to the MCF - Rush City address shown on 1st page of application form and typically takes 8-12 weeks to process before you can visit. All visitation rules/days/times and number to call to set visiting appt are on visiting potion of website. Nobody can visit unless you've filled out application and have been added to her list.

Also anyone can put money into her account so she can buy toiletries and other items by setting up an account at <a href="https://www.jpay.com">www.jpay.com</a> and you have to put in her OID/ID number which is 268928. And she can get and send mail. On website under "Family & Visitors" tab drop down and select ""Contact" then pick "Send Mail" to see what can and can't be sent. Mail to: Michelle Holte, OID # 268928, 1010 W. 6th Ave., Shakopee, MN 55379. Envelopes can't have stickers or anything on them and no decorative drawings, etc. on envelopes. If you want to send books/packages they have to be shipped from prison's approved vendor which main one is Amazon.com and has to have "gift receipt" selected. Lots of info. Call if Q's.
